Title – CDWALite – this selection allows for both individual works and more complex works within a series or collection. It also has a subelement to indicate source for a greater depth of description.

Creator – Dublin Core – this is a simple approach to creator, with the repeatable Dublin Core.

Date – VRA Core 4.0 – this allows to select a date or a range of date with the subelements of earliestDate and latestDate which seems applicable to this collection.

Description – Dublin Core – the free text field allows for a wide variety of data input.

Work type – VRA Core 4.0 – this is a valuable element in the description of art work.

Material – VRA Core 4.0 – this element with its attribute type can be helpful and descriptive for the physical characteristic of an image or work.

Measurements – VRA Core 4.0 – With this element and its attributes type and unit it is both versatile and specific in the description of an image or work.

Location/repository – CDWALite – this allows us to name the current repository and repository ID number with the subelement. Per the guidelines we can also indicate a creation location or former location.

Rights – VRA Core 4.0 – with the subelements rightsHolder and text this element provides the opportunity for rich data regarding use or restrictions.

StylePeriod – VRA Core 4.0 – defining the style, historical period, group, school, dynasty, movement, etc. of a work specifically an art collection would not only help define the work, but also allow for better access.

CulturalContext – VRA Core 4.0 – by identifying the origins or the cultural context with which the Work, Collection, or Image has been associated again not only provides for a more in-depth description, but also opens up access to the collection and its particular works.

Inscription – VRA Core 4.0 – this element helps to further identify specific works in the collection by marks or written words added to the object at the time of production or in its subsequent history. Working in digital projects and helping to digitize collections I know this is often very valuable information on a work, art or photograph.

Subject – VRA Core 4.0 – this is another helpful element in access by identifying terms or phrases that describe, identify, or interpret the Work or Image and what it depicts or expresses.

Technique – VRA Core 4.0 – this element would be helpful if you were only looking for specific techniques or methods in the fabrication of a work.
